CONDITIONS of MEMBERSHIP and REGISTRATION

1. Any person applying for membership shall only become a member after his/her application has been accepted, approved and recorded in the committee's minutes of meetings and any required transfer forms from any other club has been duly processed. **All applicants must agree to train and swim under the Club's programmes and coaches.** The committee may accept or decline any application without giving reason.
2. Every Member should abide by the Club's Constitution and Rulings. A copy of the Club's Constitution and Rulings is available on request to the Club's Secretary.
3. The Club's Registration/Membership fees and covering period, tuition/coaching fees and conditions of payment for the programme the swimmer is enrolled in are set out on a separate schedule valid on the date of application. The Club reserves the right to amend the fees and conditions of payment from time to time as it deems necessary.
4. It is the member's responsibility to inform the Registrar in writing when terminating or transferring Club membership. Transfer will be approved when all fees are paid up-to-date and all Club equipment and property is returned.
5. Registration/Membership fees and tuition/coaching fees must be paid up-to-date to allow swimmers continued participation into the next session.
6. **ALL parents/guardians of competitive swimmers** agree to assist the Club in the operation and running of Club events. Parents/guardians will be contacted by members of the Club Committee to advise when and where such assistance is required.
7. Members and their invitees are required to abide by the standards of good sportsmanship and good citizenship at all times regarding all matters arising from and during Club activities.
8. **Medical Conditions:** It is the responsibility of the parents/guardians to inform the Club (particularly the Coach) of any medical conditions which may influence the performance and/or well-being of the swimmers when participating in any Club activities.
9. Pursuant to Privacy Act 1993, the above information can be used for the purposes of communications relevant to activities relating to the Onehunga Swimming Club and details such as telephone numbers and email addresses will be passed on to coaches, team managers and organising committee members for such purposes. Membership Declaration

1. **Declaration:**
 - (a) I declare that all information supplied on the application for membership form is true and correct.
 - (b) I will keep my address and all other personal information up to date on the Swimming NZ website by using the personalised log in and password provided, or by immediately notifying in writing of any changes.
 - (c) I am not aware of any reason why I should not be issued with the membership requested;
 - (d) I understand that upon payment of my membership fee (if any) I will become a member of the club, the region and Swimming NZ and that by paying such fee each year by the due date, I will continue to be a member of my club, the region and Swimming NZ, unless I resign or my membership is terminated.
2. **Other Rules:**
 - (a) As a member I will abide by the constitutions, regulations, policies, manuals, guidelines and reasonable directions of the club, the region and Swimming New Zealand and FINA respectively.
